



THE UMC: HISTORY


- Began as spiritual renewal movement within the Church of England in the 18th century.
- Founders: John and Charles Wesley.
- Followers were branded as "Methodists" for the methodical way they ordered their lives and spiritual practice.
- In colonial America, the movement became The Methodist Episcopal Church in 1784.
- In 1968, The Methodist Church and The Evangelical United Brethren Church became The United Methodist Church.




- Born June 17, 1703 in Epworth, Lincolnshire, England
- One of 19 children born to Samuel and Susanna Wesley
- Father, Samuel, was rector at Epworth
- Mother, Susanna, is called "Mother of Methodism"
- Brother, Charles, wrote over 4,500 hymns, including "Love Divine, All Loves Excelling," "Christ the Lord is Risen Today," and "Hark, the Herald Angels Sing"



- Attended Oxford University from 1720-1724
- Ordained a priest in the Church of England on September 22, 1728
- Started "Holy Club" at Oxford with brother Charles, Robert Kirkham, and William Morgan in 1729. Lasted until 1735.



- "Methodists" known for frequent Communion and fasting two days a week.
- Beginning in 1730, visited
 Oxford prisoners and taught
 them to read, paid debts,
 found employment
- Distributed food, clothes, and medicine to poor



- April 1735 Mission to colony of Georgia
- Influenced by Moravians whom he met on journey
- Mission to Native Americans was a complete failure
- Failed courtship of Sophia Hopkey, who married someone else
- Fled Georgia and returned to England in December 1737.


• May 24, 1738 – "In the evening, I went very unwillingly to a society in Aldersgate Street, where one was reading Luther's Preface to the Epistle to the Romans. About a quarter before nine, while he was describing the change which God works in the heart through faith in Christ, I felt my heart strangely warmed. I felt I did trust in Christ, Christ alone for salvation; and an assurance was given me that he had taken away my sins, even mine, and saved me from the law of sin and death."

- Beginning in 1739, organized classes and bands
- Classes:
 - Twelve (or so) people
 - Condition for membership: "a desire to flee from the wrath to come, to be saved from their sins"
 - Rules: Do no harm; Do good; Attend upon all the ordinances of God (public worship, private prayer, Lord's Supper, searching the Scriptures, fasting)

• Bands:

- Small group of same gender and marital status
- Meet at least weekly
- Questions for admission
- Questions for each meeting

- Because Wesley was not well-received among many Church of England clergy, he sought the help of itinerant lay preachers
- In 1784, Wesley appointed Thomas Coke and Francis Asbury as "Superintendents" in North America and ordained Richard Whatcoat and Thomas Vasey as "Elders"



- Died March 2, 1791
- Other contributions:
 - "Primitive Physick: An Easy and Natural Method of Curing Most Diseases," 1740.
 - "The Doctrine of Original Sin:
 According to Scripture, Reason, and Experience," 1757
 - Influence on John Newton (former slave trader who wrote "Amazing Grace"

What makes Methodists "Methodist?" 1.0

 Salvation: "the entire work of God, from the first dawning of grace in the soul till it is consummated in glory"

• **Prevenient grace:** "all the drawings of the Father, the desires after God, which, if we yield to them, increase more and more...."

What makes Methodists "Methodist?" 1.0

• Justifying grace: "pardon... the forgiveness of all our sins"

• Sanctifying grace: being "inwardly renewed by the power of God;" having our minds changed "into the mind which was in Christ"

• The goal? "Christian perfection!"

What makes Methodists "Methodist?" 1.0

- Means of grace: "the ordinary channels whereby [God] might convey to men preventing, justifying, and sanctifying grace"
 - Examples: prayer, searching the Scriptures, receiving the Lord's Supper
- Sacrament: "an outward sign of an inward grace, and a means whereby we receive the same"
 - Examples: Baptism and Communion

2016 Book of Discipline, Paragraph 201

"The local church provides the most significant arena through which disciple-making occurs. It is a community of true believers under the Lordship of Christ. It is the redemptive fellowship in which the Word of God is preached by persons divinely called and the sacraments are duly administered according to Christ's own appointment.

Itinerancy!

2016 Book of Discipline, paragraph 338: "The itinerant system is the accepted method of The United Methodist Church by which ordained elders, provisional elders, and associate members are appointed by the bishop to fields of labor. All ordained elders, provisional elders, and associate members shall accept and abide by these appointments.

Bishops and cabinets shall commit to and support open itinerancy and the protection of the prophetic pulpit and diversity."

2016 Book of Discipline, paragraph 425: "Clergy shall be appointed by the bishop, who is empowered to make and fix all appointments in the episcopal area of which the annual conference is a part. Appointments are to be made with consideration of the gifts and evidence of God's grace of those appointed, to the needs, characteristics, and opportunities of congregations...."

Timeline:

- Fall Pastor consultation with District Superintendent
- December Church (Staff-Parish Relations Committee) and Pastor Advisory Response forms submitted; profiles updated
- February-March Appointment projections made by bishop and cabinet
- June Appointments are fixed and begin








 Both an <u>event</u> and a <u>geographical region</u> that shares ministry

Trust clause: In trust, that said premises shall be used, kept, and maintained as a place of divine worship of the United Methodist ministry and members of The United Methodist Church; subject to the Discipline, usage, and ministerial appointments of said Church as from time to time to authorized and declared by the General Conference and by the annual conference within whose bounds the said premises are

situated. This provision is solely for the benefit of the grantee, and the grantor reserves no right or interest in said premises.

2016 Book of Discipline, paragraph 2503.1

Summary: All properties of United Methodist local churches and other United Methodist agencies and institutions are held, in trust, for the benefit of the entire denomination, and ownership and usage of church property is subject to the *Discipline*." (paragraph 2501.1)

History:

Originated with John Wesley

From www.umc.org:

"Trust clauses in Methodism go back to John Wesley himself in mid-18th century England. By 1750, John Wesley had accumulated three properties as meeting places and ministry sites for the Methodist societies. He wanted to make sure that local societies could not take control of these properties from the connection he was creating. He was aware of some other religious

societies where local society members had refused to accept or sought to remove clergy or other leaders sent to them by the leaders of the larger society of which they were part. Wesley had also seen situations where people in a local society became influenced by teachings contrary to those of the Methodist movement and sought to leave while taking the society's property with them. Wesley wanted to ensure that leaders chosen by him would never be shut

out or removed by local societies. He also wanted to make certain that Methodist properties were used only and always to teach established Methodist doctrine and be available to Methodists for their ministries.

With those concerns and purposes in mind, Wesley asked several lawyers to craft deeds for the Methodist preaching houses in England at

the time. These deeds served as models for all future deeds for Methodists. In 1796, a form of these deeds, often referred to as "The Model Deed," was approved by the General Conference for American Methodists. This Model Deed and the mandate for a trust clause in all church property documents first appeared in the Book of Discipline in 1797."

Quest. What shall be done for the secur-

ity of our Church property?

Answ. 1. In all conveyances of ground for the erection of houses of Form of Conworship, or upon which they veyance for Churches. may have been already erected, let the following clause be inserted at the proper place: "In trust that said premises shall be used, kept, maintained and disposed of as a place of Divine worship for the use of the ministry and membership of the Methodist Episcopal Church in the United States of America; subject to the Discipline, usage, and ministerial appointments of said Church as from time to time authorized and declared by the General Conference of said Church, and the Annual Conference in whose bounds the said premises are situate," *

2. In all conveyances of ground for the erection of dwelling houses for the use of the preachers, or upon which they may have been already erected, let the following clause be inserted at the proper place:

* See pp. 262, 263, paragraph 3,-Eps.

"In trust that said premises shall be held, kept, and maintained as a place of residence for the use and occupancy of the preachers of the Methodist Episcopal Church in the United States of America, who may, from time to time, be stationed in said place; subject to the usage and discipline of said Church, as from time to time anthorized and declared by the General Conference of said Church, and by the Annual Conference within whose bounds said premises are situate,"

3. In all other parts of such conveyances, as well as in their attestation, conformity to acknowledgment, and placing state Laws. them upon the record, let a careful conformity be had to the laws, usages, and forms of the several States and Territories in which the property may be situated, so as to secure the ownership of the premises in fee simple.

4. Whenever it shall become necessary for the payment of debts, or sale of Church with a view to reinvestment, Property.

to make a sale of church property that may have been conveyed to trustees for either of the foregoing purposes, said trustees or their successors may, upon application to the Quarterly Conference, obtain an or-

der—a majority of all the members of such Quarterly Conference concurring, and the Annual Conference consenting—for the sale, with such limitations and restrictions as said Quarterly Conference may judge necessary; and said trustees, so authorized, may proceed to sell and convey said property: provided, that in all such cases the proceeds of the sale, after the payment of debts, if any, shall be applied to the purchase or improvement of other property for the same uses, and deeded to the Church in the same manner prescribed above.
